A SWG teleconference/web meeting was held on March 20 to recommend FGDC endorsement of the Coastal and Marine Ecological Classification Standard (CMECS). At its April 10 meeting, the FGDC Coordination Group voted to approve the CMECS for FGDC endorsement.

The ISO/TC 211 Secretariat issued draft Requirements for the ISO Geodetic Register Network (reference: <http://www.isotc211.org/protodoc/211n3294/>, dated 2012-02-24) for comments. Comments are due to the TC 211 Secretariat by May 25.

INCITS issued a request for L1 vote tally and list of delegates for USNB in response to TC 211 N 3298, Logistics information - ISO/TC 211 34th plenary and associated meetings, Toulouse, France, 2012-06-04/08. The INCITS due date is COB May 1.

INCITS issued a request for L1 vote tally and response to TC 211 N 3295, Call for hosts of ISO/TC 211 meetings. INCITS due date is April 18.

The INCITS Executive Board (EB) requested L1 to provide comments/contributions to the draft agenda for the JTC1/SC32/WG4 meeting in Berlin, Germany, 2012-06-04. Comments/contributions will be voted by L1 as the L1 comments/contributions. The INCITS due date is past.

The call for a New Work Item Proposal for a stage 0 project on management systems standards is still open.
