## Subject: A-16 Supplemental Guidance Agency Implementation Planning

The Office of Management and Budget (OMB) Circular A-16 Supplemental Guidance (A-16 Supplemental Guidance) issued by OMB on November 10, 2010, lays out a vision for portfolio management of National Geospatial Data Assets (NGDAs).

Fully implementing the A-16 Supplemental Guidance will take a number of years, therefore the Federal Geographic Data Committee (FGDC) is moving forward quickly to plan for and implement steps to realize the vision of portfolio management as described in the A-16 Supplemental Guidance.

The FGDC requests that Federal agencies submit Agency Implementation Plans within 90 days of the date of signature of this document. These plans will help FGDC, OMB, and the Federal geospatial community create a phased government-wide plan and schedule for full implementation of the A-16 Supplemental Guidance, and identify the priorities and challenges associated with implementation of portfolio management processes.

Portfolio management roles and responsibilities are outlined in the A-16 Supplemental Guidance Section 4: Roles and Responsibilities Pursuant to OMB Circular A-16, Section 8 and described in more detail in <u>Reference Document: Key Roles and Responsibilities</u>. The attached A-16 Supplemental Guidance Agency Implementation Plan Template asks agencies to focus their plans on fulfilling the roles and responsibilities that will enable effective NGDA Dataset and Theme management, which are integral components of portfolio management. All agencies are encouraged to make these roles and responsibilities operational as soon as practicale.

Implementation plans will be reviewed by the FGDC, and will help shape the Federal Portfolio Implementation Strategy. They will also be referenced in the annual Portfolio Summary Report to agency
