


Standards Task Team Objectives

- **Objective 1**: An established, maintained, and adopted list of geospatial data standards in accordance with section 2806 of the GDA.
 - **Goal 1**: Standards guidance is published on FGDC website prior to 5 year date in GDA (Sept 2023) requiring compliance with FGDC standards to spend federal funds on geospatial data
 - Action: Review and update the standards statement on the FGDC website
 - Action: Evaluation NGDA data theme leads are reviewing the current list of standards on the FGDC website and evaluating that each standard is still applicable or if any new standards need to be developed. Task team will develop process to review and update the list of standards over time
 - Action: Approval Steering Committee approve standards under the GDA (making sure that agencies will be in compliance during the Audit)
 - Goal 2: Develop and document the FGDC standards adoption and management process
 - To include such questions as: what's the vetting process for the FGDC to review/adopt standards, how will the FGDC interact with other standards bodies; how will the FGDC update and maintain the list of standards over time?
- **Objective 2**: A periodic review and determination of the extent to which covered agencies comply with geospatial data standards IAW GDA.




Fast-Track Active Standards Review

- 1. Review and recommend metadata standards
- Coordinate with NGDA Theme Lead Working Group to categorize their standards into:
 - Active
 - Inactive
 - Uncertain
- Reviewed by FGDC OS, ExCom, & Steering Committee
- NGAC endorsement
- 5. Reassess process


Annual Goal: Update the FGDC governance model and develop updated charters for the FGDC Steering Committee, subcommittees, and working groups.


Objective: Effective and efficient governance and decision making for the FGDC

- Action: Update the FGDC governance model, considering GDA and pending Circular A-16 requirements
 - Evaluate legacy subcommittees and working groups (including the role of the GDA Working Group and the NGDA theme lead groups)
- Action: Update the Steering Committee charter; develop model charters for the active subcommittees and working groups and retire inactive ones
- Action: Evaluate the GDA, A-16, and related laws and polices to identify where additional Technical Guidance is needed
- Action: Develop the Technical Guidance development, approval, and management processes

FGDC Governance

- FGDC OS finalized an initial analysis reviewing which subcommittees and working groups are still active.
- The ExCom is recommending the retirement of 4 inactive subcommittees/working groups.
- A new FGDC governance structure will be developed once Circular A-16 is finalized.
 - This new structure will be reviewed by the Executive Committee before Steering Committee final review and approval.
