Subcommittee Overview

The GDA subcommittee provides advice and recommendations related to reporting from Covered
Agencies and Lead Covered Agencies as required in the Geospatial Data Act (GDA) of 2018. Each year,
the subcommittee reviews information reported by Covered Agencies and Lead Covered Agencies,
collects, and organizes the NGAC's comments on this information, and produces a paper summarizing
these comments.

Objectives:

- Work with FGDC OS staff & NGAC leadership to plan and coordinate NGAC's submission of comments as part of the GDA reporting process
- Identify areas of focus for NGAC review and assess the utility of the reports
- Collect/synthesize NGAC's comments on the GDA reports
- Document and communicate lessons learned and recommendations for improving the process for future reports

New Role:

Follow up on the recommendations in the April 2023 NGAC GDA Implementation paper
