## Federal Geographic Data Committee Coordination Group Meeting September 1, 2009 MEETING MINUTES

General/Intros/Upcoming Meetings/Summary of Action Items: Welcome and Introductions: Ken Shaffer, FGDC [presentation] FGDC Business Update FGDC Secretariat Report

The meeting commenced with opening remarks.

The FGDC Business Update, the Secretariat Report and the CG Agenda Items will now be combined into one presentation. This will supplement the set of read-ahead's and will be used as a walk-through of the topics covered at the meeting. Use the Secretariat Report to gain context to the read – ahead's. Materials will not be presented in full at the meeting; it is the responsibility of the attendees to review the material prior to the meeting, as stated in the CG operating procedures.

**IFTN CG Discussion:** IFTN calls for a Program Management Office (PMO) with ½ FTE of dedicated staff from three organization, NDOP, USGS and USDA.

DHS comments: This IFTN ROD will be overcome by events if it doesn't move now. Microsoft is starting to fly aerial photography and this action will eliminate the Federal government from providing public domain products. There is speculation that this will be intense competition and Microsoft will not be willing to share their products with the federal government.

Response: The intent is to stand up the PMO in the first ½ of FY 2010 and the IFTN Phase 1 Plan to address the stand-up is already in active development.

**Action Item 20090901-01:** DHS will distribute to the CG the imagery prioritization plan they use.

**Action 20090901- 05:** Meet at NCPC on September 9 from 9:00 to 12:00 for a discussion regarding a potential strategy for the revision of the Geo LoB contract and to rebase the remaining 2009 activities and the 2010 tasks.

**CG Operation Guidelines Document** is a living document. When changes are made they will be put into the monthly business report for the CG members to see.

**Annual Report Discussion:** Challenges from the CG offsite and future recommendations to fix those challenges should be added to the 2009 Annual Report. Another challenge could describe

the scope of the NSDI.

**Action Item 20090901-02:** The FGDC Secretariat will forward to the CG the Challenges that by agencies for inclusion into the FY09 Annual Report.

**Place-Based Policy and Programs Memo**: The ExCom will talk with OMB and others regarding the Placed Based memo. This memo is focused on leveraging place-based programs to more effectively improve an area. The question that should be asked is how we can support the place-based initiative rather than asking what examples to we have to show what geospatial management can do.

# Summary of the August, National Geospatial Advisory Committee Meeting – John Mahoney, FGDC [presentation]

John provided a summary of the NGAC August 26-27 meeting in Shepherdstown, WV and stated that the meeting minutes and presentations will be shared on the FGDC web page.

The NGAC endorsed the IFTN Record of Decision by resolution. They included in the resolution endorse of seeking authorized funding and to create an FY 2011 Budget Initiative.

**Action 20090901-06**: The NGAC has developed a draft metrics paper and would like feedback from the Geo Lob Lifecycle WG.

National Geospatial Forum will focus on just a few topics: the Place Based Initiative and Geospatial Policy.

Emerging Technologies – what are the impact of cloud computing and other technology on a Geospatial Policy? Stephen Lowe, USDA SAOGI will be a liaison on this topic.

The FGDC Secretariat is in the process in sorting out the new NGAC nominations for members whose terms will expire at the end of January 2010. FGDC will be establishing a review committee and may reach out to a couple of CG members for participation.

# **Update on the Geospatial Lifecycle Working Group Theme Discussion: Wendy Blake-Coleman, EPA** [presentation]

The Lifecycle WG has not received any comments on the Lifecycle presentation or the document from the CG presentation on August 4. All the information is posted to the myUSGS.gov shared site. Wendy would appreciate comments and would like to come to closure on this by early October. The WG thought that CG members may not have bought into the idea and/or understand National Geospatial assets, including theme coordinators, scope of the A-16 geospatial data portfolio, scope of the NSDI, what data sets belong on the A-16 lists, etc. A goal of the Lifecycle WG is to make the A-16 portfolio understandable to the masses. The potential alignment of the proposed A-16 themes needs the CG members review.

**Comment:** There is a need to address cross cutting themes. For example the energy theme is crosscutting with various other themes; there should be a dialog across the themes.

# Harmonization on the Revisions of the Charters for Standards, Technology and Architecture, and Metadata Working Groups – Lew Sanford, FGDC [template]

#### GeoSpatial Line of Business 2011 Concurrence Status – Ivan DeLoatch, FGDC

An emergency meeting was called on August 31 regarding the status of continuing the GeoLoB. OMB is supporting the GeoLoB through FY 2010. The FGDC would like to get concurrence with the Steering Committee on this and to date, 12 agencies have not yet responded. We are taking steps to call the non- responding agencies individually. A summary from the Steering Committee vote will be provided when the tally is complete. There still is work in the groups that need to finish before they can be sunsetted. Ivan is awaiting guidance from OMB on how to deal with the GeoLoB after FY 2011.
