Intergovernmental Coordination (John Mahoney)

- The purpose of the intergovernmental coordination effort is to provide a mechanism for the Geospatial Platform (Platform) to reach out to partners in State, local, Tribal, and regional government. The President's FY2011 Budget calls for intergovernmental coordination.
- Two options for working on intergovernmental coordination were presented to the National Geospatial Advisory Committee (NGAC).
 - Establish a Federal Advisory Committee Act (FACA)-authorized Intergovernmental Subcommittee of the NGAC.
 - Create a non-FACA Intergovernmental Subcommittee of the Federal Geographic Data Committee (FGDC), consisting of representatives of non-Federal governments.
- NGAC concurred that the Platform should establish a FACA-authorized Intergovernmental Subcommittee of the NGAC. Platform leadership agreed to use this approach.
- Platform and NGAC leadership may consider adding individuals to the Subcommittee to incorporate a full range of the competencies needed to guide the development of the Platform.
- The development of the intergovernmental coordination process is intertwined with the development of the stakeholder engagement process and the development of the Managing Partner.

Stakeholder Engagement (John Mahoney)

- Platform leadership received good feedback and constructive ideas from NGAC membership on a path forward for stakeholder engagement.
- The Modernization Roadmap for the Geospatial Platform (the Roadmap) has undergone a Federal review process. The Office of Management and Budget (OMB) has given approval for more extensive engagement from non-Federal stakeholders for their thoughts and suggestions for improvement on the Roadmap.
- The Roadmap v3 is posted on www.GeoPlatform.gov.
- Platform leadership will do a concentrated outreach program over the next 60 days.
- Platform leadership will use some social media techniques such as IdeaScale to generate feedback and discussion.
- NGAC will benefit from tools to assist in communicating the goals and value of Platform to non-Federal stakeholders, including background papers, slide presentations, etc. The ExCom will work with the CG to update background papers, slide presentations, etc. for use in communicating with non-Federal stakeholders.

<u> Managing Partner (Tony LaVoi)</u>

- Tony provided a brief overview of the Managing Partner discussion with NGAC and the ExCom.
- The key roles identified for the Managing Partner are:
 - Project Sponsor/Executive Champion.

- Project Stakeholders/Board of Directors.
- Project Manager.
- The key criteria identified for selecting the Managing Partner are:
 - Agency interest and commitment.
 - Core capabilities.
 - Leadership skills.
 - Credibility.
 - Operational experience.
- Three questions were posed to the NGAC to foster discussion of the Managing Partner:
 - Are there innovative organizational options that should be considered when developing the model for the Managing Partner organization?
 - Are there essential criteria that must be factored into the decision of the Managing Partner organization?
 - What are the core operational functions required for a successful Managing Partner function?
- NGAC discussed several key points concerning the Managing Partner.
 - It is difficult to engage stakeholders without knowledge of the Managing Partner.
 - The Platform should think about high-level constructs before details.
 - The first question answered should be: what are the core "mission" requirements?
 - Identify alternatives and criteria for selection.
 - It's a business needs that kind of focus.
 - Strong understanding of geospatial (does the Managing Partner need to have it?).
 - There will never be a "perfect" candidate.
- Participants stressed a sense of urgency that the Managing Partner needs to be decided on soon. The Administration measures success in weeks and months, so action is required quickly.
- Participants discussed splitting the Managing Partner into two functional components. These components are:
 - Policy/Governance.
 - Operations.
- Participants reviewed the proposed responsibilities, capabilities, components, and characteristics needed for the Managing Partner. These were presented in Policy and Operation buckets.
- Participants discussed the implications for governance, service-level agreements, and other interactions among and between the two core functions.
- Using this information as a set of criteria, Randy Fusaro will lead a small group of CG members to go through and look at agencies and identify which agencies best fit the core criteria.
- GSA presented their capabilities to be the Managing Partner, as well as their geospatial needs. GSA offers communications capability through mechanisms supporting Data.gov, including Chief Information Officer (CIO) Council

engagement and other employees at departments/agencies involved in data, business case development support, and other attractive features.

- ACTION ITEM: Distribute GSA's presentation to the CG.
- Participants discussed GSA's current capabilities to immediately implement "Platform as a Service" by leveraging infrastructure that is already in place. A potential next step is using Gartner to evaluate current models.
- Participants discussed GSA being the Managing Partner. Discussion topics included:
 - Leveraging current investments.
 - Knowledge of the customer.
 - Budgetary incentive/disincentive.
- Based on the ExCom meeting, the ExCom will work with GSA to develop a business case with alternatives. GSA has employees to help Platform leadership with a preliminary business case. This business case would be the cost of the entire Platform, not just the Managing Partner.
- Participants agreed that it is critical to develop a business case and understand the necessary investment.
- GSA recommended finding high-value, easy wins that they can support.
- GSA has a "venture capital" like fund. Under this fund, GSA is presented with an idea, they evaluate return on investment, make a funding decision. Participants recommended using geocoding as a pilot for the venture capital option.
- ACTION ITEM: Email the CG next steps from the ExCom session.
- The next FGDC CG meeting will be held on October 12, 2010
