 - First DATT for the Geospatial Platform Modernization Roadmap V4.
 - Intent is to utilize this same approach for each major document for which the CG requires formal adjudication action.
- TOR outlines the operating procedures for a DATT
 - Purpose, approach and responsibilities of a DATT, provides basic guidance on document versioning and naming controls.
 - Defines the responsibilities of the CG, DATT lead, DATT members, DAT PMO Support (if applicable), FGDC Secretariat.

- Should the first round of theme adjustments include a broader array of themes associated with manmade features?
 - Yes-so that NGDA datasets can be mapped to the themes as identified
 - No- add these as the need arises when a new NGDA data set is identified that falls within this category
- If yes-how closely should the new themes align with the HSPD-7 sectors
 - There is no presumption that all of these themes would be managed by a single agency just as all HSDPD-7 sector are not managed by a single agency

- 2011-01-12 Meeting vote Cancellation of Project 1574-D, Geographic Information Framework Data Content Standard
 - Project was canceled due to lack of activity within INCITS L1
 - INCITS Secretariat directed L1 to vote on reasons that the project was canceled.
 - The reason for cancelation was that the project had not progressed; moreover, it was too difficult to re-construct the paper trail of reviews.
 - Geographic Information Framework Data Content Standard is an FGDC-endorsed standard.



- 2011-01-12 Meeting vote ISO/TC 211 Standard for systematic review – ISO 19105:2000 Geographic information --Conformance and testing
 - ISO 19105 is not among the 64 FGDC-endorsed external standards, nor is it in the DoD IT Standards Repository (DISR) – more discussion of DISR later in the 2011-01-11 CG meeting.
 - ISO 19105 specifies general principles for describing how geographic information products and services are expected to conform to the standards developed by ISO/TC 211.



- 2011-01-11 Meeting vote ISO/TC 211 Standard for systematic review – ISO 19132:2007 Geographic information -- Locationbased services -- Reference model
 - ISO 19132 is among 64 FGDC-endorsed external standards.
 - ISO 19132 is not in DISR.
 - A description of the standard may be found at <u>http://www.fgdc.gov/standards/fgdc-endorsed-external-</u> <u>standards/index_html</u>.
 - Location Services are identified in the Modernization Roadmap for the Geospatial Platform Version 3.0 as standards that should be formally evaluated for adoption by the Federal Government.



- 2011-01-12 Meeting vote DIS 19144-2 Geographic information — Classification systems — Part 2: Land Cover Meta Language (LCML)
 - ISO 19144-2 establishes a metalanguage for a set of objects and rules (language) to describe land cover features that may be part of different land cover legends (nomenclature), thus providing a framework for comparing different classification systems and nomenclatures.
 - L1 will vote on a recommendation that the standard be submitted to ISO for publication and on a recommendation that the standard be adopted as a U.S. standard.



- 2011-01-12 Meeting vote DIS 19117 Geographic information — Portrayal
 - This standard is a revision of the first edition (ISO 19117:2005)
 - ISO 19117 specifies a conceptual schema for portrayal data, in particular symbols and portrayal functions.

ISO Technical Committee 211

- ISO/TC 211 plenary and associated meetings were held 2010-12-06/10 in Canberra, Australia.
 - INCITS L1 serves as the U.S. Technical Advisory Group (TAG) to ISO/TC 211.
 - INCITS L1/U.S. TAG voted to approve the U.S. delegation to the ISO/TC 211 meetings.

ISO Technical Committee 211

- ISO 19142:2010 Geographic information Geographic information – Web Feature Service was recently published as an International Standard.
 - INCITS L1/U.S. TAG voted to adopt ISO 19142 as an American National Standard.
 - OpenGIS® Web Feature Service Implementation Specification, version 1.1.0 is among 64 FGDC-endorsed standards. It is also among the standards in the DISR.
 - The Geospatial Intelligence Standards Working Group (GWG) will evaluate ISO 19142 as a replacement for WFS 1.1.0 in the DISR. Technical maturity and implementations will be considerations in evaluation.



FGDC/ISO/ANSI/OGC Process Alignment

- GWG/FGDC process alignment (to be discussed later in 01-11 CG meeting) poses considerations for FGDC alignment with other standards processes (ISO, ANSI, OGC).
- Federal representatives will have already voted on standards being vetted through external standards organizations.
 - Questions:
 - How do Federal representatives set position for vote? Do they "socialize" standards under consideration within their organizations to set position for vote, or do organizations leave it to their representatives to set position?
 - What does vote mean to Federal organizations? Does the vote signify endorsement and use by the Federal organization?

NGAC Intergovernmental Subcommittee

Purpose:

- Interim body to provide advice and recommendations in the development of the Geospatial Platform
- Members:

- Initial Tasks: The Intergovernmental Subcommittee will review and provide feedback on the following issues:
 - Are there specific offerings (data, services, applications) available from State/Regional/Local/Tribal governments that should be pursued for integrating with the Federal Geospatial Platform in the short term?
 - What are the incentives that the Federal government should consider providing to encourage non-Federal contributions to the Platform?
 - What are the best mechanisms for identifying ongoing requirements for the Platform and potential contributions to the Platform from our State/Regional/Local/Tribal partners?



The National Map Subcommittee Recommendations

The NGAC approved the following recommendations:

A key component of the geospatial platform must be an integrated set of foundational data layers for the nation. The National Map (TNM) represents the primary existing effort to provide this service. TNM should focus on providing this foundational data, across a wide range of scales, as its primary purpose, in partnership with an array of data providers in accordance with A-16. The foundational layers should align with the FGDC Framework, with the addition of geographic names.

Parcels should be incorporated as one of TNM's base data layers. A lead agency or agencies should be identified as federal integrator(s) of parcel data.



FTC Report: "Protecting Consumer Privacy in an Era of Rapid Change"

The NGAC approved the following recommendation:

RECOMMENDATION: The NGAC recommends that the FGDC work collaboratively with the Federal Trade Commission (FTC) to seek clarification of language addressing geolocation in the FTC Staff Report, "Protecting Consumer Privacy in an Era of Rapid Change." The members of the NGAC are concerned about the imprecise use of the term "precise geolocation data" in the report. The lack of definition and clarity in the language could cause significant unintended consequences to the geospatial field, resulting in impacts to consumers, government programs, and industry. The NGAC is willing to work with FGDC and FTC, as needed, to help provide the perspective of the geospatial community to this issue.
