- It replaces the NSGIC State Summaries
- Developed by a NSGIC Work Group
 - Led by Danielle Ayan (GA) and Mike Ouimet (TX)
 - Danielle's time was funded by FGDC
- A common, credible baseline assessment methodology to routinely and continuously monitor and validate statewide geospatial capabilities
- 83 detailed questions that characterize the geospatial programs of each participating state

TIMELINE

- Survey officially opened on August 2, 2011
- Requested completion of Section 1 by September 9, 2011
- Requested completion of entire Assessment by November 4, 2011
- The Assessment was downloaded in mid-November to represent 2011 and then the states will modify their results as needed in the future
- We will prompt them for annual updates
- The 2011 database will be maintained as spread sheets and a relational database

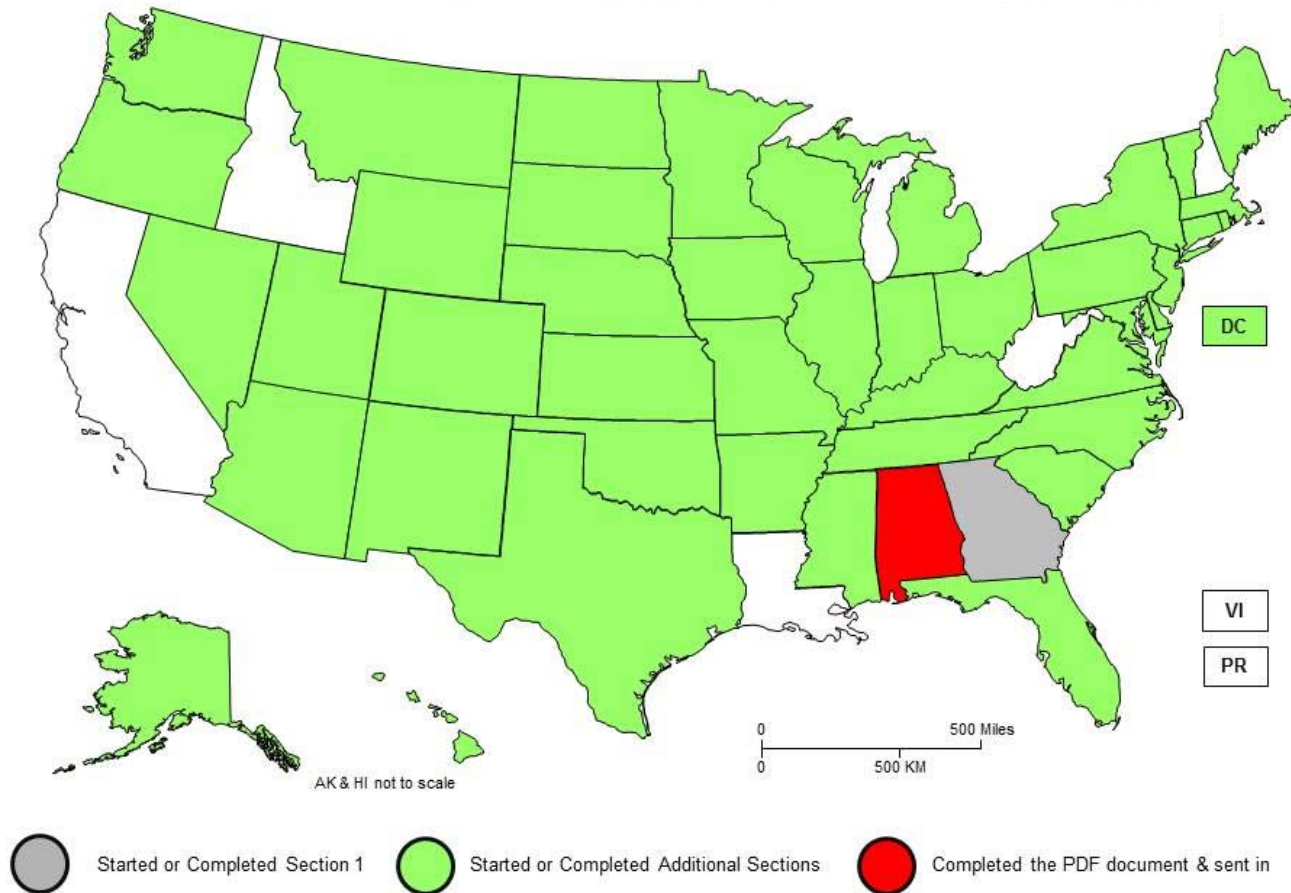
