Welcome and Introductions - Ivan DeLoatch, FGDC OS; Wendy Blake-Coleman, EPA

Ivan DeLoatch, Chair of the Coordination Group, called the meeting to order. Members were asked to introduce themselves.

Previous Meeting Action Item Review - Arista Maher, FGDC OS

Arista Maher reviewed the action items from the previous meeting and provided a status report on each item.

FGDC Business Report – Ivan DeLoatch, FGDC OS

Ivan reviewed the meeting's agenda, followed by reports on FGDC committees' recent activities and decisions. The most recent Steering Committee (SC) meeting took place in April 2012, and the most recent ExCom meeting took place in March 2012. The membership changes for both CG and SC in the last month were discussed. The only new addition this month was that Harvey Simon replaced Jerry Johnston as the new EPA Senior Agency Official for Geospatial Information (SAOGI).

The next SC meeting will take place on September 20, 2012 at the American Institute of Architects' (AIA) Board Room. The next ExCom meeting has been scheduled for August 27, 2012 at Main Interior. The next National Geospatial Advisory Committee (NGAC) meeting will take place on September 18-19, 2012 at AIA. A call for nominations for new NGAC appointees was issued on June 4. Nominations are due by July 19. CG members are asked to widely circulate the nominations

information to interested parties. A brief report on the NGAC subcommittees that recently met was given. The next CG meeting will take place on Tuesday, August 14; the location is yet-to-be determined, due to possible construction in the room at NCPC. The Secretariat will provide details prior to the meeting.

The Geospatial Line of Business and Geospatial Platform update contained information on the current status of Geospatial Platform "Groups," consisting of public/private membership for collaboration on specific topics. The Hurricane Response Group, for instance, is focusing on providing data and map views for hurricane response efforts. The Group is currently being established, determining roles, and registering data and services. The Group plans on evaluating content for data and service gaps and to ensure consistency. It will reach out to other partners such as states for better collaboration. The Group hopes to demonstrate its progress at an upcoming ExCom or Steering Committee meeting. Another Group is centered on the National Environmental Protection Act (NEPA), which hopes to utilize the Geospatial Platform's capabilities to support environmental regulation.

A brief update was given regarding Geospatial Line of Business/Geospatial Platform Managing Partner activities, including the Interagency Agreement Document status and status of tasks undertaken by the PMO. The FGDC will be showcasing the Geospatial Platform at the upcoming Esri International Users' Conference in July 2012. CG members were informed of an opportunity to showcase agency activities in the FGDC exhibit.

The Cooperative Agreements Program (CAP) 2013 category suggestions are currently under review. CG Members were thanked for their input. The FGDC Secretariat staff is drafting content for the FGDC Annual Report. CG members have been asked to provide contributions to the report as well.

An update on FGDC Standards activities was given. The Coastal and Marine Ecological Classification Standard has been posted to the FGDC website. The FGDC Standards Working Group membership is under review. The next Standards Work Group meeting (date TBD) will focus on the INCITS withdrawal of INCITS 145-1986 and FGDC participation in GWG.

The status of standards-related CAP projects for 2011 and 2012 was reviewed as well. Regarding INCITS L1 activities, the ISO TC 211 34th Plenary and meetings were held June 4-8, in Toulouse, France. L1 met June 14 at Esri to discuss results of ISO TC 211 34th Plenary and meetings.

U.S. Government Country Codes Standard Status Update - Deborah Anderson, NGA

Deborah Anderson presented on the Geopolitical Entities, Names, and Codes standard. Formerly, a Federal Information Processing Standard (FIPS) was used as the U.S. Government's country code standard for many years, followed by use of non-governmental standards (as prescribed by Federal law). The International Organization for Standardization (ISO) 3166 – "Codes for the Representation of Names and Countries and Their Subdivisions, Part 1 – Country Codes and Part 2 – Country Subdivision Code" has been identified as the standard to which the U.S. Government should transition, but first it must be profiled for U.S. Government use.

The Department of Defense has been directed to implement a U.S. profile of ISO-3166-1 by September 30, 2012. The National Geospatial-Intelligence Agency (NGA) is leading a Country

Codes Working Group (CCWG) for coordination of country code requirements and maintenance of the U.S. Government profile of ISO-3166.

The Geopolitical Entities, Names and Codes (GENC) standard will be the U.S. Government profile of ISO-3166. This standard provides an authoritative set of country codes and names for use by the Federal Government in information exchange. A U.S. government profile of ISO-3166 is necessary for countries, subdivisions, and/or names for which the U.S. Government does not agree with the sovereign nation on, and for code elements for geopolitical entities needed by the Federal Government for information exchange purposes that are not recognized by the ISO-3166 Maintenance Agency (MA) for inclusion in the ISO-3166 standard.

ISO-3166 allows for the standard to be extended via user-assigned code elements. The migration strategy from FIPS 10-4 to GENC will use the regular ISO-3166-1 code element when possible, and use user-assigned code elements (alphanumeric, in order to remove conflict with ISO code elements) when the ISO code elements are not available. The CCWG is being used as a DoD/Federal intelligence community forum for coordinating country and subdivision codes and managing the content of a country codes registry.

NGA is developing a registry to host country and subdivision code data as part of the National System for Geospatial Intelligence Standards Registry (NSG Reg). It is available at: <u>https://nsgreg.nga.mil</u>. The GENC standard is a standard specifying the structure and management for the nominal "U.S. Government Profile of ISO 3166." It contains data structure documentation and sample data content and normatively references the applicable parts of the (dynamic) GENC Registry for specific data content for country code elements, subdivision elements, and geopolitical correlations. A draft should be ready in early July 2012, and publication is expected in September 2012.

The next steps are to: coordinate with the National Information Standards Organization (NISO) regarding transitioning from a U.S. Government standard to a U.S. national standard; to identify additional code requirements and incorporate those deemed within scope of the CCWG; and, to provide appropriate coordination for those of relevance but outside the scope of the CCWG. A mediation service will also be established to monitor progress of the transition.
