## Committee's Decisions Summary

- The Steering Committee endorsed the "Geospatial Investment Definitions for Tracking and Reporting Geospatial Investment Costs" document.
- An Executive Committee Meeting will be scheduled to discuss the GAO response in connection to the National Address Database, and the creation of an Address Theme. The goal is to obtain consensus and to develop a joint strategy to further a National Address Database.
- The Proposal to change the name of the "Biota" NGDA Theme to "Biodiversity and Ecosystems" was presented to the Steering Committee. Next steps in the process include:
  - The Coordination Group will vote on their recommendation for Steering Committee endorsement of the change.
  - The Steering Committee will vote which will include concurrence with OMB as the FGDC Vice Chair.



# Committee's Decisions Summary

- The CG Chair discussed the public release of the of the NGDA Dashboard in near future
  - ❖ Steering Committee members were encouraged to review and become familiar with the content of the dashboard and the supporting reports from their agency
  - The Steering Committee members raised not objections to this plan of action

# 2014 GAO Engagement – Actions Status

#### ❖2015 GAO report FGDC actions (3 remaining)

- Correct search function on Geospatial Platform and monitor regularly
  - Status: Technical, and catalog record content improvements: on-going
- Regular collection of Geospatial Platform performance measures with reports to Steering Committee
  - Status: Metrics and dashboards being designed and developed
  - Includes service performance, NDGA Lifecycle assessments, portfolio
- Create address data theme and associated subcommittees and working groups to further a national address database
  - Status: ExCom/SC agree on:
    - Federal government should have a leadership role
    - National addresses should be an NGDA
    - Supporting subcommittee/working group should be established
  - Further ExCom deliberation on:
    - Which Federal agency(ies) should have theme lead responsibilities
    - Where in the NGDA Themes are addresses aligned

  - Reorganize Biota and Land Use Land Cover NGDAs

- Redesign of Theme Lead Collaboration Community (TLCC)
  - Will be re-titled the NGDA Collaboration Community (NCC)
  - Anticipated release May 2016 with GeoPlatform Release 4
- ❖ Theme Administrative Assessment
  - Revise earlier version and will discuss with Theme Leads and Coordination Group







# Standards in the queue – following publication

- ❖ISO/DTS 19115-3 Geographic information --Metadata -- Part 3: XML schema implementation of metadata fundamentals
  - ISO/TC 211 secretariat to forward the final text of 19115-3 to the ISO Central Secretariat for publication.
  - Limit date for publication: June 26, 2016
- ❖ISO 19157-2 Geographic information -- Data Quality Part 2: XML Schema Implementation
  - Limit date for publication: May 27, 2016
