Four recommendations to FGDC - GAO report March 2015 (GAO-15-19)

Correct search function on Geospatial Platform and monitor regularly

Technical, and catalog record content improvements: on-going

Regular collection of Geospatial Platform performance measures with reports to Steering Committee

Metrics and dashboards being designed and developed

Create address data theme and associated subcommittees and working groups to further a national address database

Pilots being led by DOT and the Census Bureau continue

NDOP to reassess the feasibility of the Imagery for the Nation initiative, identify discrete steps that could be taken to further a national imagery program for all levels of government

- Initial assessment provided to SC and CG in September
- Co-leadership of the Imagery theme and changes in the subcommittee structure to include satellite expertise in discussion

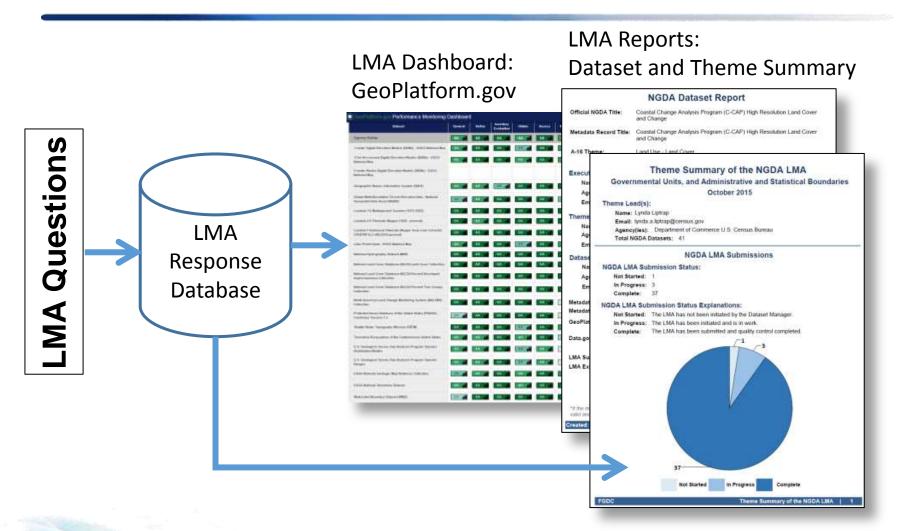

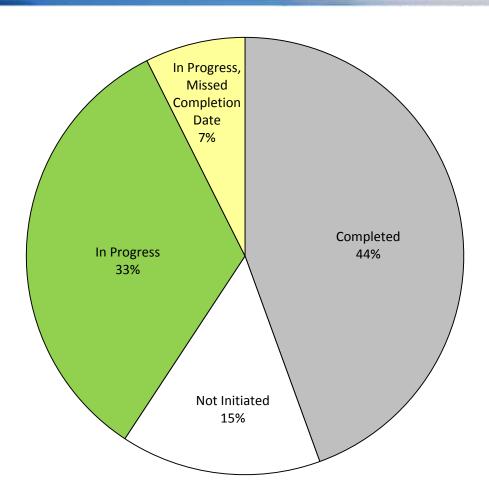

#### Address Data Standard

United States Thoroughfare, Landmark, and Postal Address Data Standard (Address Data Standard)

- ❖ Public review ends April 25, 2016
- Federal Register notice, <a href="https://federalregister.gov/a/2016-01337">https://federalregister.gov/a/2016-01337</a>, provides information and instruction for submitting comments



#### Address Data Standard

- ❖ The primary purposes of the Address Data Standard are to develop content specifications for address information; provide classifications for different types of addresses; establish appropriate standards and measures for evaluation of address data quality; and support exchange of address data.
- ❖Over the last 5 years, a number of desirable minor corrections to the Address Data Standard have been identified.
- ❖The U.S. Census Bureau has proposed adding a new Map Position element.



## Standards status log

- ❖ February 2016 marks the 5<sup>th</sup> anniversary of the standards status log.
- ❖ The standards status log now tracks over 300 standards from FGDC, INCITS Technical Committee L1, ISO Technical Committee 211, Open Geospatial Consortium and other geospatial-related standardization activities.



## Standards status log

- ❖ The FGDC OS is informally surveying the geospatial community about use of the standards status log.

#### INCITS/L1 and ISO/TC 211 officers

- ❖ ISO/TC 211 recommended that the ISO Technical Management Board (TMB) accept the re-nomination of Mr. Olaf Østensen as ISO/TC 211 chair for one year. Norway has announced its intent to relinquish the ISO/TC 211 Secretariat.
- ❖ The INCITS Secretariat issued a request for INCITS/L1 input on US acquisition of the ISO Technical Committee 211 Secretariat.
- ❖ The INCITS Secretariat issued a call for volunteers to chair INCITS/L1. Dr. Liping Di's second term ends in July 2016.
