Committee's Decisions Summary

- ❖ On May 31st, the Executive Committee will meet to discuss the National Address Database and the GAO response. The goal is to obtain consensus on whether to establish an address theme or use another approach to manage the NAD, the datasets that will be part of the theme, and who will have leadership roles.

- ❖ Public release of the Performance Dashboard, and the NGDA Lifecycle Maturity Assessment (LMA) Reports
 - ❖ Steering Committee members were encouraged to review and become familiar with the content of the dashboard and the supporting reports from their agency and to provide feedback by May 6th.
 - ❖ The plan is to post the Dashboard and the LMA reports publicly on May 16th.

Committee's Decisions Summary

- ❖ A vote to approve the change of the name of the Biota Theme to Biodiversity and Ecosystems Theme was sent to the Coordination Group, votes are due back on May 20th.

INCITS/ISO 19115-1:2014[2014] Geographic information - Metadata - Part 1: Fundamentals

- Defines the schema for describing geographic information and services with metadata. It provides information about identification, extent, quality, spatial and temporal aspects, content, spatial reference, portrayal, distribution, and other properties of digital geographic data and services.

- ISO 19115:2003 and CSDGM will be retained as FGDC-endorsed standards for legacy purposes

FGDC Standards WG meeting

INCITS/ISO 19157:2013[2014] Geographic information - Data quality

- establishes principles for describing quality of geographic data.
- defines components for describing data quality;
- specifies components and content structure of a register for data quality measures;
- describes general procedures for evaluating quality of geographic data;
- establishes principles for reporting data quality.

FGDC Standards WG meeting

INCITS/ISO 19157:2013[2014] Geographic information - Data quality

- Defines a set of data quality measures for evaluating and reporting data quality. It applies to data producers who provide quality information that assess and describe how well a data set conforms to its product spec and data users who determine whether or not the geographic data are of sufficient quality for their application.
- Does not attempt to define minimum acceptable levels of quality for geographic data.
