FGDC Business Highlights, Ken Shaffer, FGDC OS

Committee Decisions

Andrea Travnicek, Ph.D., Acting Assistant Secretary for Water & Science is serving as acting FGDC Chair. Tim Petty's nomination hearing was this week. He has been nominated to be the Assistant Secretary for Water and Science. The FGDC OS will keep the Coordination Group informed.

The FGDC Executive Committee held a workshop on December 8th to discuss the future direction of the Geospatial Platform.

Steering Committee

The next Steering Committee meeting will be held once the FGDC Chair is designated and agencies reaffirm or designate their Senior Agency Official for Geospatial Information (SAOGI), In the meantime, the Executive Committee will continue to meet and provide direction.

Executive Committee

The Executive Committee held a GeoPlatform session on December 8th. A follow up meeting is scheduled for the week of January 26th in 2018. FGDC plans to hold a similar session with the Coordination Group on January 23rd.

National Geospatial Advisory Committee (NGAC)

The NGAC meeting was held via webinar on December 11th. Agenda topics:

• FGDC Updates

- Subcommittee Reports
- Public Comment Period
- Discussion on potential future study topics

The NGAC meeting focused on the subcommittee reports and activities.

- Landsat Program
 - o Task 1: The team will provide a draft paper on possible architectures for future Landsat missions to the NGAC prior to the April 2018 meeting.
 - o Task 2: A draft report on temporal data cubes was provided to the NGAC for comment. The NGAC will provide comments by January 19th.
 - o Task 3: A status report on the paper about fee recovery options for Landsat data will be provided to the NGAC for their review prior to the April 2018 meeting.
- Geospatial Technology and Infrastructure Subcommittee: The NGAC adopted the subcommittee's paper pending minor changes.
- Cultural and Historical Geospatial Resources Subcommittee: Will develop best practices document in 2018, and are working on a draft letter to be sent to interview subjects.
- Data as Services Subcommittee: Will develop a draft position paper by April 2018, and a final draft by September 2018. The next step is to set up a panel discussion for the NGAC with data service providers.

The NGAC will issue a call for nominations in spring 2018 for the next round of appointments to the NGAC.

FGDC Coordination Group Meetings

The CG meeting dates for 2018 were presented.

National Geospatial Data Asset (NGDA) Portfolio Management

- Theme Implementation Plans: A Theme Lead meeting was held on 12/5. There is ongoing progress in the development of the Implementation Plans. An actions progress table will be inserted in themes summary reports. The plans will be posted on geoplatform.gov as they are available.
- 2017 LMA Dataset, Theme Summary and Dashboard status: By January 2018 theme leads and dataset managers will generate draft dataset reports and theme summary reports and will be shared with the Coordination Group for their review and approval.
- 2017 LMA Analysis & Recommendation Report: Will be reviewed by dataset managers, theme leads, and CG between January-February 2018.
- 2018 NGDA Web services and Metadata Project: Phase 2 of the metadata project kicks off in January 2018.
- The Coalition of Geospatial Organizations (COGO) NSDI Report Card: The FGDC continues to work with COGO to arrange meetings with their review teams and NGDA theme leads. The Elevation and Geodetic Control themes are still trying to identify review team members. Most of the themes are finalizing their draft reports. FGDC encouraged COGO to reach out the theme leads. The report card is scheduled to be released in March 2018.

Geospatial Platform Contract Support

There are 2 tasks orders supporting the Geospatial Platform.

Technical Support

- The technical team continues to support operations and maintenance of GeoPlatform.gov. There are 3 planned releases of new capability in 2018.
- Cloud hosting services: The Geospatial Platform and FGDC offer a managed service for geospatial assets to FGDC member agencies, more information at https://www.geoplatform.gov/hosting
- GeoPlatform Release 10 deployed on December 1st. Key features are knowledge graphs, recommender services, and new collaboration communities.

Portfolio Management

- Provides ongoing support for 2017 Lifecycle Maturity Assessment (LMA) activities.
- Continues to support A-16 communities' operations and maintenance.
- Supports NGDA database and FGDC webpages as required.
- Adjudicating theme leads comments for draft NGDA LMA dashboard.

The USGS Capital Planning and Investment Control (CPIC) activities are complete. Continue review and updating of artifacts for FY18.

Metadata Working Group, Lorna Schmid, FGDC OS

Lorna Schmid reported on the Metadata Working Group (MWG) activities. The membership of the working group was reviewed.

Activities:

- The MWG met last September. Discussion topics included Status of ISO 191** Suite of Metadata Standards, proposal for endorsement of ISO standards, best practices document review, and highlights of the ISO metadata summit.
- The Steering Committee endorsed 2 INCITS/ISO metadata standards, and 2 other metadata related standards are advancing through the FGDC approval process:
 - o 19115-1:2014 Geographic information -- Metadata -- Part 1: Fundamentals and
 - o 19157:2013 Geographic information -- Data quality standard
- ISO Metadata Implementation Forum: This is a monthly webinar information series for the presentation and discussion of ISO metadata implementation.
- Metadata guidance and best practice: Worked with agencies to manage documentation. Updated the NGDA Metadata Guidelines.
- ISO Metadata Summit: Participated on ISO Tools sessions, presenting 6 tools. Several presentations were made throughout the summit. Report from the summit is available online.

Next steps

- Update documentation to incorporate information on new and retired standards, and other relevant updates. Learn best way to identify metadata standards endorsed by FGDC.
- Update crosswalk towards ISO 19115-1 implementation.
- Continue to work to endorse standards through the FGDC process.
- Continue to work with geoplatform.gov and Data.gov teams on access and incorporation of agency metadata.

Geospatial Standards Activities, Julie Maitra, FGDC OS

Julie Maitra reported on Geospatial Standards activities.

FGDC Standards Working Group:

• There are 10 proposals for FGDC endorsement of external standards. Many of them pertain to the Open Geospatial Consortium (OGC) standards.

INCITS L1/U.S

- A number on international standards projects are in progress, including metadata standards such as "Preservation of digital data and metadata".
