Welcome and Introductions, Ivan DeLoatch, FGDC OS

Ivan DeLoatch welcomed the Coordination Group and public attendees to the web meeting and provided a brief overview of the agenda. Participant's introductions were made.

Previous Meeting Action Item Review, Lucia Foulkes, FGDC OS

The actions from last month's meeting were reviewed.

FGDC Business Highlights, Ken Shaffer, FGDC OS

Ken Shaffer reported on FGDC business activities. Highlights included the following:

Committee Decisions Summary

On December 16, 2016 the Steering Committee approved the National Spatial Data Infrastructure (NSDI) Strategic Framework document.

The FGDC Recommendations for the 2017 Transition paper was approved on December 9th. This document is written from a federal perspective and is limited to one page (front and back).

The Department of Homeland Security (DHS) also developed a paper to emphasize the federated relationship between the Geospatial Platform (public) and the DHS Geospatial Information Infrastructure (GII) (sensitive but unclassified) platform.

CG and SC Monthly Membership Changes

Ted Payne, will no longer serve as SAOGI for the U.S. Department of Agriculture. The secretariat will inform the community when the new SAOGI is appointed.

Steering Committee

The Steering Committee meeting will be on March 23rd, 2017 at DOI, South Penthouse. The agenda is in development.

NGAC Update

The NGAC met on December 14. The agenda topics discussed included: FGDC Update, NSDI Strategic Framework, NGAC Transition Documents and Strategy, and Subcommittee Reports.

The NGAC endorsed the FGDC NSDI Strategic Framework document. In addition, they approved two transition documents:

- The "NGAC 2017 Transition Recommendations"
- The "NGAC 2017 Transition InfoGraphic"

The NGAC also adopted two papers:

- The NGAC "Comments on OMB Circular A-16 and the Geospatial Policy Framework" paper
- The NGAC "Emerging Technologies and the Geospatial Landscape "paper

John Mahoney reported on the subcommittee current activities and noted that the Standards Coordination Subcommittee and the Landsat Advisory Group will be reviewing their draft papers at the March meeting.

Coordination Group meeting dates

2014 Government Accountability Office (GAO) Engagement

The Address subcommittee had their first meeting last December. The meeting notes from this meeting were sent to the GAO at their request.

National Geospatial Data Asset (NGDA) Management Plan and Portfolio Management

In 2017 Theme Leads will have monthly meetings alternating first Thursdays and first Tuesdays. Their first meeting was on January 5, 2017.

Data.gov transitioned to the cloud. One of the changes is that federal and non-federal metadata publishers will be required to use an OMB max account. For more information see https://www.data.gov/meta/data-gov-infrastructure-migration-notice-federal-non-federal-users

The Theme Implementation plans template was discussed during the Theme Lead meeting on January 5th. These are five year plans for each theme to help increase dataset maturity, develop partnership and other activities. The framework themes had started to work on this and there are a lot questions about the format of the templates. All themes are required to have plans by April 28, 2017.

The 2017 LMA process is underway. There is a core team in place. The release of the report is anticipated in May 2017.

Americas Inventory of Parks and Protected Areas: An overview of the Protected Areas Database of the United States (PAD-US), Lisa Johnson, (USGS Gap Analysis Program Cooperator - Boise State University)

Lisa Johnson provided an overview of the Protected Areas Database of the United States (PAD-US).

PAD-US is the official inventory of protected open space in the United States. PAD-US is published the US. Geological Survey Gap Analysis Program (GAP) and it includes spatial data of natural, recreational, cultural and historical value, from small sites to larger areas, recreation to habitat. A protected area consists on areas held in the public trust; a broad definition that includes places such as the National Parks, State P arks, National Monuments, National and State Forests, State Wildlife areas, and city parks.

Ms. Johnson discussed the vision of PAD-US and highlighted the features and capabilities of the database with a demo. She also talked about the role of the Federal Lands Working Group (FLWG) to ensure that PAD-US includes the best available representation of federally owned lands and management designations. After the demo, there were questions about authoritative data and PAD-US. Ms. Johnson clarified that PAD-US is an aggregator and that the agency managing the data is the authoritative source.

Some of the next steps included enhancing the database. The PAD-US team is also looking for partners to complete the database, and will be working on improving federal data, supporting states, and doing more outreach.

Ivan DeLoatch, FGDC chair suggested to look into sharing this information via the Geospatial Platform and explore integration of PAD-US into geoplatform.gov

Geospatial Platform PMO Activities Update, Janet Hoyt, Mason, Bruce & Girard, Inc.

Janet Hoy provided an overview of the Tasks summaries and reported on the current Geospatial Platform PMO activities:

- Cloud hosting Services: The geospatial platform and FGDC are offering cloud hosting services for geospatial assets to FGDC member agencies. More information can be found here: https://www.geoplatform.gov/hosting
- Release 7 of the Geoplatform.gov will focus on tools to manage portfolio resources and metadata.

Ms. Hoyt reported the monthly Capital Planning and Investment Control (CPIC) reporting activities are completed.

NSDI Strategic Framework, John Mahoney, FGDC OS

John Mahoney reported that in December 2016 the Steering Committee approved the National Spatial Data Infrastructure (NSDI) Strategic Framework. The document was also endorsed by the NGAC. The document is available on the FGDC website at https://www.fgdc.gov/nsdi-plan/2017/nsdi-strategic-framework.pdf

The first draft was developed based on responses received from the public comment period. The final draft addressed the comments received through public comment period, in addition to meetings with FGDC committees, NGAC, and the Leader's Forum meeting.

The next step is to distribute the document within the community and engage with the new administration in 2017 to refine the framework and collaborate with partners to develop implementation approaches to address the goals and strategies.

Mr. Ken Shaffer noted FGDC is in the final stages of finalizing the status update of the NSDI Strategic Plan actions.
