Committee's Decisions Summary

- ❖ On December 16, the FGDC Steering Committee approved the *National Spatial Data Infrastructure (NSDI) Strategic Framework* document.
 - ❖ Describes a broad national approach for the continued sustainable development of the NSDI.
 - ❖ Includes goals and objectives for the Federal government's role and also includes strategies and possible actions for the greater geospatial community to work collaboratively on broader national issues.
 - ❖ The final framework addresses comments received through the comment period and through the most recent meetings with the FGDC Steering Committee, the NGAC, and the Leaders Forum. The NSDI Core Team has adjudicated the comments and made updates and changes to the plan where appropriate. Committee's Decision Summary

- ❖ The *FGDC Recommendations for the 2017 Transition* paper was approved on December 9th. This document is written from a federal perspective and is intended for use by the DOI and other FGDC agencies to inform the incoming Administration of its importance, opportunities, and broad support across the community. The document is being limited to one-page (front and back).
- ❖ The *Department of Homeland Security (DHS) Geospatial Information Infrastructure (GII)* paper was developed to emphasize the federated relationship between the Geospatial Platform (public) and DHS GII (sensitive but unclassified) platform.


- ❖ Restarting web services and metadata project
 - ❖ Federal and non-Federal metadata publishers are required to have an OMB MAX account – see instructions <https://cms.geoplatform.gov/resources>
 - ❖ Coordinate with NGDA Dataset Managers and Theme Leads to work towards an end of April completion for updating metadata records with web services and download links and publishing to Data.gov/Geoplatform.gov
- ❖ Theme Implementation Plans Status
 - ❖ Updated template available <https://cms.geoplatform.gov/A-16-NGDA-Theme-Community>
 - ❖ Framework Themes due in February and all Themes are required to report by 4/28/17 (for Oct. 2016-Mar. 2017 reporting period)

❖ 2017 draft template will include more details and draft will be distributed in summer as new LMA is underway




❖ 2017 Lifecycle Maturity Assessment

- ❖ Anticipate online LMA release in May 2017 with all NGDA assessments complete by Dataset Managers by August 2017
- ❖ Assessment Question Development Status
 - ❖ Completed Administrative and General Questions
 - ❖ Finishing Stage 1 Define/Plan (e.g., business requirements process, stakeholder engagement, quality assurance process, etc.)
 - ❖ Finishing Stage 2 Inventory/Evaluate (e.g., list of data assets and data gaps - both internal and external)
 - ❖ Working on Stage 3 Obtain (e.g., collection, purchase, conversion, transformation, sharing, exchange, or creation of geospatial data)
 - ❖ Beginning on Stage 4 Access (e.g., making data produced known and retrievable by the community)
 - ❖ Beginning Stage 5 Maintain (e.g., ongoing processes and procedures to ensure the data meet business requirements)
 - ❖ Stage 6 and Stage 7






- ❖ The FGDC Standards Coordinator is preparing a consolidated directory of FGDC-endorsed standards and other significant standards-related documents.
